

# An Update From David & Simon

After 18+ months of Zoom meetings and milestones, the power of place has never been more clear to our team. So we're thrilled to tell you about a few historic properties we're currently working to buy: the Garden House on Beacon Hill and the Good Arts Building in Pioneer Square!

Ownership of historic places is a key part of our work, and one of the best ways to ensure community use in perpetuity. We currently own nine historic properties around the city – from the Good Shepherd Center and Washington Hall, to the Cadillac Hotel and affordable housing buildings. The Garden House and Good Arts Building are in perfect alignment with our mission of saving meaningful places to foster lively communities.

Both deals are expected to close by the end of the year, pending due diligence. We're currently raising \$25,000 to fund our due diligence work in the meantime – you can support this effort by donating online at historicseattle.org/give

We'll be able to share more about these deals in early 2022 & look forward to hosting programs at both properties.

## Jeff & Eugenia Fill You In

Landmarks Preservation Board meetings may still be virtual, but they seem busier than ever these days. Here's a short summary of recent and upcoming advocacy activity – sign up for our eNews for more substantial regular updates!

- The Panama Hotel was nominated for landmark status at the Dec. 1 LPB meeting; Historic Seattle submitted this nomination with support from the National Trust for Historic Preservation and Jan Johnson, the property owner.
- Historic buildings owned by religious entities are more threatened than ever as development pressure continues and property values rise, as shown by plans to demolish the former IBEW hall by Churchome in Belltown and First Presbyterian Church in First Hill. A Washington State Supreme Court ruling exempts properties owned by religious entities from landmark regulations.
- The UW has been voluntarily nominating several properties, including the Faculty Club and Wallace Hall. Both were nominated in November and will be considered for designation later this month. We support landmark status for both and encourage you to do the same.
- The Showbox controls and incentives date was extended to February 2. We'll update you on whether this date will hold, or be extended yet again, in January.

Remember, advocating is a verb. It's up to you to take action to save meaningful places that foster lively communities.

# Cindy's Parting Words

Looking back over my 40 years with Historic Seattle, I find myself focusing on various sets of memories, from the many executive directors with whom I have worked (five in total), to the volunteer governance that I have supported (some of whose tenure with the organization goes back almost as far as mine), to the many properties acquired and restored by our real estate arm. Somehow, it is the many and varied places where I have worked that rise to the surface when I reflect. Most who know the organization cannot picture us as being anywhere else than the Dearborn House, but there was much that went before.

I first joined the staff of HS when their offices were located on the 12<sup>th</sup> floor of the Smith Tower in Pioneer Square, at a time when our IBM Selectric typewriters represented the most advanced office technology of the day. My most recent workplace was my upstairs home office on Queen Anne Hill, working remotely during a global pandemic. In between? There were stints in several Pioneer Square properties, both owned and rented, in the historic Dearborn House on First Hill when it was donated to us in the late 90s, as well as the Good Shepherd Center in Wallingford. All of these locations represented the organization recovering, growing, responding to opportunities, pivoting, and making the most of the unique set of powers it holds as a public development authority.

Through all these years and locations, I have been motivated and inspired by the mission of the organization. I always felt that I was part of a group accomplishing the valuable work of preserving places in Seattle that are important to all our residents. I look forward to watching this crucial and timely work continue even as I move onto my next chapter.
